Broker/Agent Participation Guidelines

1. A commission will be paid based on the following terms to any properly licensed Real Estate Broker/Agent who submits his or her client's bid(s) according to the guidelines as outlined below and whose client is the successful purchaser of the property. Their client must close on the property and must pay the Total Contract Price for the property in U.S. funds to receive the following commission:

A. Two Percent (2%) commission of the gavel price will be paid.

2. The Broker/Agent commission will not exceed Two percent (2%) of the gavel price of the property purchased by the Broker/Agent's client.

3. In order to be entitled to any commission, the broker/agent must complete the following steps:

A. Register his or her client by filling out the Broker Registration Form in full, including the signature of the client on the form. Submit the Broker Registration Form via mail, fax or email for receipt before the deadline of June 27, 2017 by 5pm ET in order to receive the full 2% commission. Broker Registration Forms submitted between 5pm ET, June 27th, 2017 and 5pm ET June 28th will only be eligible for a 1% commission of the gavel price.

- D. The commission will be payable only at closing and will be disbursed by the escrow agent.
 - E. The Broker/Agent will hold harmless and indemnify Premiere Estates Auction Company, Inc. and Richard Buckingham, Engel & Volkers-Richmond, from any and all claims with regard to such commission.
 - F. The Broker/Agent will be paid a commission only as set forth under these guidelines and only as pertaining to the specific property being auctioned.

 - H. The Broker/Agent shall provide an Agency Disclosure to their Buyer/Bidder listed above prior to the Auction.
 - I. This form consists of three pages and that the Broker/Agent has received all pages.
5. All bids must be submitted in U.S. dollar amounts, and all bidding must be done in accordance with the U.S. dollar. The Broker's/Agent's Buyer/Bidder, by placing his or her signature below, certifies, agrees and acknowledges that:
- A. He or she has inspected the premises of the subject property.
 - B. Richard Buckingham, Engel & Volkers-Richmond, represents the Seller in this transaction. Premiere Estates Auction Company, Inc. is representing the Seller only as an auctioneer in this transaction. Commission shall be paid only to Broker/Agent representing client (Buyer/Bidder) as an Agent as acknowledged in this form. If another Broker/Agent has not registered him/her with Seller or Premiere Estates Auction Company, Inc.
 - C. He or she shall hold harmless and indemnify Premiere Estates Auction Company, Inc., Seller and Richard Buckingham, Engel & Volkers-Richmond, from any and all representations made by you the Broker/Agent.
